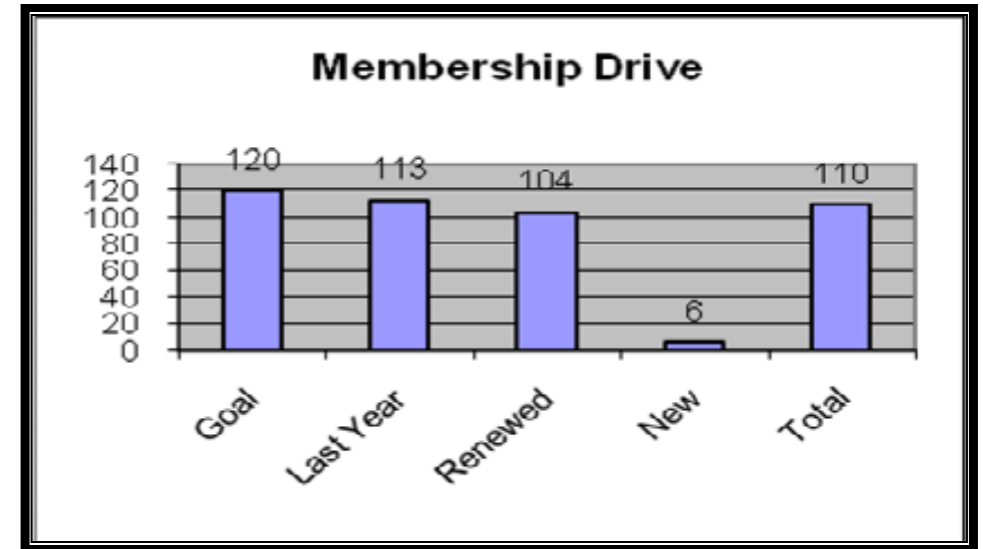

# Presidents Corner

This month I want devote my letter to an explanation on how the state funding works and what it means to our club. First of all let me remind you that your club due goes to support your club, but also the AWSC, Association of Wisconsin Snowmobile Clubs. Who is the AWSC? The AWSC is the state organization that works with the Wisconsin State Government in developing safety programs, and state funding to support the volunteer clubs in the state of Wisconsin. Of your annual membership dues of \$20.00 half of that amount or \$10.00 goes to cover your individual membership in the AWSC. Why is that important, because they are your lobby group to support the Snowmobile State Funding Program? Without the state funding your club would not have the resources to maintain the trail system we have.

Today we manage approximately 100 miles of trail system. Of those 100 miles 72.6 miles are state funded trails at a rate of \$230.00 per mile. What does that mean to you? Based on a per mile basis we have a guarantee fund of \$16,698.00 to draw upon to cover our expenses. During the 06'/07' snowmobile season your club spent \$34,114.00 to support our trail system. Where does the money go? The largest expense is grooming cost, last year we spent \$22,915.00 in grooming our trails. We also invested \$4,323.00 in grading expense; \$1,000.00 went for AWSC Dues, \$1,556.00 for landowner insurance, over \$1,200.00 for appreciation dinners for our landowners, crop damage, signs, bridges, mailing costs, just to mention the major expenses.

What expenses can the club claim against our State Funding? We can claim grooming expense, signs, and materials used to build bridges, and labor and equipment cost to prepare the trails for the season. Last year your club members put in over 450 hours of volunteered time in getting our trails signed and brushed for the season. They keep track of their time worked and their personal equipment used on State Forms. We are allowed to bill back that labor and equipment cost back to the state. Their volunteer time gives us the opportunity to generate income needed to support our club through the state funding program.

So how do we get from \$16,698.00 in guarantee state funding to our actual expenses in the 06'/07' season? In addition to the guaranteed state funding for our club the state has what they call Supplemental Snowmobile Funding. This is a pool of funds that are paid out over and above our annual state funding. The idea behind this portion of funding is that in a given year not all parts of the state get snow, there for the clubs that did have a good snow year and incurred additional cost in grooming,

etc. can draw from that Supplemental Fund. We as a club going into the year do not know how much reimbursement we will get from the Supplemental Fund. It can be 100%, 80% or something in between, it all depends on how much snow we get and in what parts of the state get snow. Most years the Northern Counties generally go in to Supplemental Funding and the Southern Counties due not.

This year is a great snowmobile year for the entire state. That being said I believe that all the 600 clubs across the state will be applying for Supplemental Funding which could make our payout from that pool of funds as little as 40% to 50%. We also because of the excellent snow year will be incurring additional grooming expense this year. That being the case I think it will be safe to say the Revenue will not match Expenses. Fortunately your club has some reserves to get us through this year. Those reserves were generated with the volunteer labor our club members gave in supporting the club. Without their support your club could not exist, so if you see someone working on the trail stop and say Thank You. They deserve it. If you would like to get more involved in our club please come to our next meeting. We need all the help we can get. I hope you found the article informative and interesting as to how our club is financed.
