Registration for the overnight club ride was discussed. The club will ride to the Rhinelander area on Super Bowl weekend.

The minutes/report from the November 3, 2018, meeting was not sent out electronically.

There was a discussion on the idea to update/refresh the Bagley & Brazeau Joyriders club logo and then sell club merchandise. Adam Krause will draft several logo ideas and share them at an upcoming meeting. A motion to approve the logo update was made by Adam Krause and second by Gary Trader. Motion approved.

There was a discussion on how to document/log your time when working on the trails. It is important to track vehicle, equipment and manhours separately so it can be entered in Snowmobile Automated Reporting System (SNARS). It is also necessary to enter an email address in SNARS for each person who is logging work. Please include your email address when submitting work/equipment logs. Appreciation was expressed for all those working the trail system.

#### **Trail Reports:**

Some of the fields have large dirt boulders due to the frost settling in so quickly after the fields were chisel plowed. Groomer, Hubert Wiedemeier, has gone out to break up some of the boulders.

There was a discussion on the fact that some of the gates that need to be opened for the start of the season are keyed and the club does not have the necessary keys. There are also several gates that are broken and in need of repair/replacement.

Funding was approved for recreational bridge in Langlade County. This now needs zoning and DNR approval. If all approvals are received, the bridge could go in by 2020.

A change was made to the trail by Wescott Lake as requested by the landowner.

There is a washout on the trail in Suring that goes to the golf course. This is in the area where the bridge used to be; it will be corrected with sand.

The new trail by White Potato Lake is ready to go.

The new trail by the National Forest is brushed and ready to go. Grooming in that section of the trail will be completed up to Jack Pine Lane.
