### October 5, 2019 Member Minutes

### October 5, 2019 Minutes

The meeting was called to order by club president Roy Lawrenz at Ron & Kim's Lee Lake Tavern at 9:00 a.m. Thirteen members were present.

#### **First Order of Business:**

Secretary Report – The minutes from the last meeting did not include adjournment, which was made by Steve and Gary. In addition, there was discussion on the work that was completed by Kelly Lake and Round Lake. The election of club officers was done. It was a clean slate, all club officers remain in their positions. A motion to approve the report was made by Hubert Wiedemeier and second by Linda Holtger. Motion approved.

### **Treasurer Report**

Income and expenses were discussed. The year-end financial statement is available - the year goes from September – October 1. \$1360.00 donation was made to the Brazeau Rescue Squad. Two landowner certificates are sent to each landowner. There are currently 89 landowners. A motion to approve the report was made by Tom Stadler and second by Tom Yingling.

#### **New Business**

Oconto County Alliance Meeting - Club president, Roy Lawrenz attended the meeting and shared meeting highlights. The Oconto County Alliance is asking for photos of the work being done on the trails. GPS Tracking for groomers – GPS tracking will be mandatory for all groomers next season, 2020-2021. There was a discussion on how to track time when the groomer may not be moving but the groomer driver is out doing labor on the trail.

Map proof reading – there are two dates for map proof reading. The club is still working to establish the new trail. The club is hopeful they will receive permission from one last landowner. The trail map will reflect the old trail as it is now.

The trail bosses were given a copy of the spreadsheet listing all landowners. Roy asked that the spreadsheet be reviewed for accuracy.

The club received a bill for approximately \$1300.00 for landowner's insurance. A motion to approve payment was made by Brad Vanhoof and second by Tom Stadler

Membership – 74 members have renewed with three new members registering.

The club bought a new pole saw and now has two good working pole saws available for trail work.

Trail Report – Mark Radtke volunteered his tractor and completed some trail work. Butler Springs trail has been cleared and widened. Gate 425 to the southeast has been cleared as far as possible. Much work has already been done on the trails with additional work being planned for after the meeting.

The club needs to order new envelopes. A motion to purchase 1000 additional envelopes was made by Tom Stadler and second by Linda Holtger.

Adjournment: A motion was made by Tom Yingling and second by Cheryl Paasch.
