### Third Order of Business:

Approval of Treasurer's report. Chuck reported that income for September included a state funding check in the amount of \$7570.51 and club dues totaling \$1380.00. Expenses were \$650.66 for a net September income of \$8299.85. Current club assets total \$61,691.

Jerry Frey motioned to approve treasure's report, second by Bob Peters. Report approved.

### **Fourth Order of Business-Old business:**

Copies of proposed By-law changes were handed out to members. Tom Yingling and Jane Garrow, members of by-law committee, discussed some of the proposed changes and revisions. After a brief discussion, Joe Ryba made a motion to approve the by-law revisions, Chuck Panure second. By-law revisions approved.

Tom Stadler stated the new by-laws would be posted on the website as soon as the committee provides a final copy.

### Fifth Order of Business—New business:

 Tom Stadler stated there is an Oconto County Alliance Meeting on October 7<sup>th</sup>. Tom and Brad Van Hoff will attend. Signs will be ordered at this

- meeting and trail changes will be discussed. Tom talked about the new color/number system for county trails. Chuck requested they ask if more information could be provided with payments. Checks are received without much detail/explanation of what the payment is for.
- 2. Roy reported the Landowner Appreciation Dinner has been rescheduled for April 9, 2021. Romy's has been reserved.
- 3. Meeting Schedule and club events. It was discussed that all meeting dates need to be posted on the website. With the uncertainty of establishments closing due to the pandemic, it was decided that Roy will arrange the location a few weeks ahead of each meeting. He will do this in time to include in the newsletter.
- UTV lite groomer update. This was discussed at last meeting. Roy has not talked to Tom Kuchta but hopes to next week. He will update at next meeting.
- 5. Trail Report—Steve Garrow reported he used the stump grinder on all the stumps on the trail along Marl Lake Road. Chuck reported he is having issues with one landowner who feels snowmobilers wrecked his fence. There was discussion on possible alternatives, none of which seem plausible. Tom will talk to Brad about possibly talking to the landowner. Tom reported that Brad has talked with all the landowners that make up the trail from Champeau Road to Suring. This year the trail will run through fields instead of on the road to the railroad grade. Tom reported that he still needs to call his landowners but does not anticipate any issues. Tom Yingling reported he has contacted all of his landowners. Tom handed out trail maps to all trail bosses present. The maps have trail sections marked indicating the sections each person/team is responsible for marking and maintaining. He will get the maps to those trail bosses who were not at the meeting. Tom talked about some of the work to be done after the meeting. He also indicated that utility lines along old 64 will be buried and poles removed. When that happens, we may need to use a workday to clear rocks along that trail.
